Thank you for becoming a transfer partner of Western Governors University (WGU). We share your goal of providing affordable and accessible degree programs to all of your graduates.

Under the terms of this agreement, WGU will:

1. Provide transfer tables for all related computer information systems degree programs. These tables show the credits that transfer to a WGU IT bachelor's degree program, and, the courses required at WGU to complete a bachelor's degree. 2. Graduates and staff of BHCC are eligible to apply for scholarships offered by WGU. Scholarships can be found at: http://www.wgu.edu/tuition_financial_aid/scholarships; and
3. Participate in transfer events and other related activities hosted by BHCC.

In return, we ask that BHCC:

1. Maintain a link between the BHCC and the WGU landing page for partner college graduates and staff;
2. Maintain current brochures describing WGU degree programs and services in your counseling/transfer offices. WGU will provide these materials at no charge;
3. Include information about WGU programs and services in communications sent to impending graduates and prospective transfer students.
