### MoStemWINS Grant Pharmacy Technician Certificate Program Application Steps

1. All MoStemWINS pharmacy tech applicants must enroll at [www.jobs.mo.gov](http://www.jobs.mo.gov) which is the Missouri Job Center Website. This is a Department of Labor requirement for all grant participants.
2. Complete the MoStemWINS application at [www.mineralarea.edu/MOWINS](http://www.mineralarea.edu/MOWINS).
  - Click on the Apply Now! Button
  - Click on the MoStemWINS-Pharmacy Technician application and complete the online application.
3. Applicants will be contacted within three business days by a MoStemWINS grant support specialist.
