Comments:

1.1: Directions are provided to the Blackboard LMS. The class outline indicates an introduction to the course during the first session. It is assumed the introduction will also cover the LMS.

1.2: The purpose of the course is clearly stated in the syllabus.

1.3: Since the class does not include an online component, etiquette expectations (sometimes called "netiquette") for online discussions, email, and other forms of communication are offered as suggestions. *Examples include:*

- Be sensitive to the fact that there will be cultural and linguistic backgrounds, as well as different political and religious beliefs, plus other differences in general.
- Use good taste when composing your responses in Discussion Forums. Swearing and profanity is also part of being sensitive to your classmates and should be avoided. Also consider that slang can be misunderstood or misinterpreted.
- Don't use all capital letters when composing your responses as this is considered "shouting" on the Internet and is regarded as impolite or aggressive. It can also be stressful on the eye when trying to read your message.
- Be respectful of your others' views and opinions. Avoid "flaming" (publicly attacking or insulting) them as this can cause hurt feelings and decrease the chances of getting all different types of points of view.
- Be careful when using acronyms. If you use an acronym it is best to spell out its meaning first, then put the acronym in parentheses afterward, for example: Frequently Asked Questions (FAQs). After that you can use the acronym freely throughout your message.
- Use good grammar and spelling, and avoid using text messaging shortcuts.

1.4 The syllabus covers course activities, grading policies, and attendance. Consider addressing academic dishonesty policy.

1.5: Hands-on equipment needed is addressed. Since the online component of the course is not mentioned, consider adding minimum requirements so students can access online content without difficulty.

1.6: No prerequisites are listed in the syllabus.

1.7: Minimal skills for students entering the course are not listed.

1.8: An instructor introduction is not provided in the syllabus. This rater was unable to access the online course site.

1.9: Nothing in the syllabus indicates explicitly that students are asked to introduce themselves. It is assumed this will happen during the introduction phase of the course. Consider setting up online discussions so that students can interact with each other online, outside the classroom.

2.2: A general statement that outcomes will be connected to assignments each week is included. Consider listing specific outcomes to each listed activity in the syllabus.

2.3: The course learning objectives/competencies are listed in the syllabus. Consider adding the specific assignment objectives.

2.4: The specific assignment objectives are not listed.

2.5: The objectives are suited to the level of the course.

3.1: The specific assignments/assessments are not listed. The syllabus states that weekly assignments and a final exam/project will be used for assessment.

- **3.2:** The course grading policy is stated in the syllabus.
- **3.3:** Specific criteria for assessments are not provided.

3.4: The assessments (weekly assignments and exams) are sequenced and align with the course content.

3.5: Weekly assignments and exams provide opportunities to track progress.

4.3: The individual assignments do not contain citations. It is assumed the assignments/assessments are related to the text. Consider adding citations to point students to particular areas of the text/course content.

4.4: The text is current (2012).

4.5: A variety of materials is provided.

4.6: No mention is made of optional, or extra credit, assignments or activities.

Comments:

5.1: Specific learning activities were not listed in the syllabus. This is a computer-based text for certification, so it is assumed the activities align with objectives.

5.2: The syllabus states that individual work is expected, with some group work accepted.

5.3: No plan is provided for classroom response time or assignment feedback. Consider adding something to the effect: "I will try to return assignment feedback within 5 days." "I will answer email messages within 48 hours." Policies like these, for example, will cut down on student anxiety over feedback and relieve extraneous inquiries from students.

5.4: Requirements are listed in the syllabus.

7.1: Not specifically addressed in the syllabus. Since the class is in a lab setting, it is assumed tech support is available. It is recommended that multiple channels of tech support communication be listed in the syllabus to ensure that no student is put behind due to technical difficulties.

7.2: A general ADA compliance statement is made, along with a statement directing any student with special needs to contact the correct EMCC office, with the contact information provided. No listing of broader policies is included. A link to EMCC's disability services information is included.

7.3: The Student Success Center is listed in the syllabus.

7.4: Access to support services are listed through the Student Success Center.

**The following are suggestions for an online component to this course

8.1: No link to the online site was provided. This rater is unable to comment on the actual content. The following are suggestions for best practice in course design.

8.2: Information regarding the accessibility of technology used is not included. This would include instructions on how to obtain and install any programs used.

8.3: In addition to varying the modality of content through text, audio, and video instruction, the Americans with Disabilities Act requires institutions to make accommodations for student who identify as having a disability. Work closely with your institution's office for disability services to identify resources to assist in making your course ADA compliant. For videos, a transcript or videos that are captioned are required as an effective means of communication.

8.4: Pay special attention to fonts, text color, and background color. Most learning management systems have a default appearance that is ADA compliant. Also, be aware that screen reader software will not recognize bold or italicized fonts. Check with your office of disability services before changing the appearance of your course.

8.5: When possible, embedding multimedia within the course LMS ensures ease of access and limits student issues that may arise when leaving the LMS to access outside resources.

Background

Funded by a \$13 million grant from the U.S. Department of Labor, *Maine is IT!* is building new educational and career pathways in information technology at all seven of Maine's community colleges. The programs funded by the grant are designed to support Maine workers eligible for the Trade Adjustment Assistance (TAA) program, un/underemployed adults, and workforce needs in Maine's growing IT sector. They have been built to serve individuals with a range of experience, from those interested in gaining basic IT skills to IT professionals looking to advance their careers through new industry certifications.

Overall Remarks and Reviewer Summary

In reviewing CST162 several processes and data collections tools were noted and identified. This reviewer took in account the Dynamic Skills Audit conducted in 2014-2015. Both qualitative and quantitative data was identified in the report that provides the key elements:

- 1. Career opportunities do exist within 100 miles of EMCC for graduates possessing a these skills. It was also found by this reviewer that the skills mastered in CST162 relate to specific job openings.
- 2. Current job openings list specific duties that relate to network security. The current Advisory Board indicates it contributes to the labor market data.

There are several current job openings available for Network Security (as of 5/14/17) within a 100-mile radius of SMCC. A Network Support Technician is currently being sought in Portland, ME. Job description lists "is responsible for the monitoring, maintenance, and repair of all IT Systems. This responsibility includes, but is not limited to, servicing the daily needs of the call centers and regional offices; maintaining the operability and stability of servers used to host applications and services; planning and implementing new systems and services as needed."

The Dynamic Skills Audit outlined the following process, which this reviewer took into consideration when compiling this the formal SME report:

- 1. Local industry needs were assessed through the program Advisory Board. Minutes from those Advisory Board meetings were reviewed and suggestions from the partnerships were adopted into this summary.
- 2. Burning Glass data was reviewed to identify themes and trends in the current job market. The Burning Glass report helped identify skills demanded by employers to curriculum outcomes and learning objectives.

A formal SME was conducted with the above reports and compiled in the next section of this report.

Findings include:

The CST162 course learning outcomes and objectives align with the program mission and goals. This reviewer found that the CST162 course has listed measurable outcomes which can be stacked and latticed with other coursework. The industry sector for CST162 has been categorized as: NAICS 541512 Systems Integration Design Services. (See: https://www.naics.com/naics-code-description/?code=541512) The reviewer finds that this classification is correct.

Those completing this course would enter the Bureau of Labor Statistics occupation classification of 15-1152 Computer Network Support Specialists.

This course was designed for community college students or equivalent. There are no course prerequisites listed.

Listed course objectives include:

- Identify the various elements of wired and wireless networks, including network cables, network interface cards, switches, etc.
- Describe the various network topologies for LANs and WANs.
- Describe the OSI Reference and TCP/IP network models.
- Identify and describe various network protocols and utilities and their application in networking.
- Apply knowledge of networking requirements and components in various scenarios.

The content of these course objectives aligns with the topics listed in the course syllabus and the required textbook. This alignment also correlates to items found within the Dynamic Skills Audit and Burning Glass baseline skills as listed in the labor market data.
