## MEDICAL BILLING & CODING CERTIFICATE PROGRAM (M046): ACADEMIC MAP

This Academic Map is a term-by-term Academic Graduation Plan course schedule outline for student who plans to start the program in the FALL semester. The milestones listed to the right of each class are designed to keep you on course to graduate in 3 consecutive semesters, including Summer. This Academic Map serves as a general guideline to help you have a minimum of a part-time schedule each term and complete the program as intended. The Health Information Management (HIM) courses must be completed to satisfy all the program requirements unless you have these requirements successfully transferred in from another college as Transfer Credit or the student successfully completes and passes the equivalent Challenge Exam. Students are only allowed to transfer in or challenge out of a total of 1/2 their course work required for graduating the program. Milestones are courses and special requirements necessary for timely progress to complete the program. Missing milestones will result in one of two types of map registration stops. The first level (Academic Probation) is when a student has missed a milestone (course failed and/ or GPA not met) for the first time in the major. If a student is in non-compliance with milestones for two (2) consecutive semesters, a student will receive an (Academic Dismissal Letter) from the Academic Affairs Office and a student is automatically dropped from the program, and cannot return for a minimum of at least 1 semester.
