Overall Summary:

This course syllabus on Advanced GTAW (TIG) Welding aligns to industry standards and is a model for duplication. This course allows students to focus on vertical and overhead positions with GTAW using a variety of materials. As a recommendation, it may be valuable to add ANSI Z49.1 as topic in the course outline to cover other safety topics not mentioned. Another safety reference that may add value to use is the American Welding Society Safety & Health Fact Sheets. Under course objective number 6, the student is to follow the visual acceptance quality requirements of AWS D1.1 which deals with 1/8 (3mm) plate and thicker. It may be valuable to reference inspection criteria from other sources such as AWS D9.1: 2012 Sheet Metal Welding Code or AWS D17.1 2010 Specification for Fusion Welding for Aerospace Applications. It may also be valuable to change Section III, Part D "Electrode stick out" to "Arc length" since this is GTAW.
