Course Description	Familiarizes the student with business, personal and industrial uses of microcomputers. All of the below mentioned are available on most of the classroom computers and ALLSOP computer lab located in Nielsen Hall at Kirkwood. Other locations on campus including the library <u>may not</u> have the correct version of Microsoft Office and be compatible with MyITLab. You will need to use Microsoft Office 2013 or Office 365 to complete the Pearson assignments.</p> <p>Windows 7 or Windows 8 Operating System is preferred, but you may use a different version. A few MyITLab and video demonstrations will be shown using Windows 7 or Windows 8, but the same tasks can be completed using other operating systems. It is your responsibility to determine any differences.</p> <p>Microsoft Office 2013 or Office 365 should be used in this course. Note: You may use other versions of office, but they may not contain some of the color schemes and options needed for assignments and points <u>will not be</u> adjusted to compensate for having the wrong software. The Microsoft Office software package should contain Word, PowerPoint, Excel and Access. Note that student versions of Microsoft Office often does not include Access. Office 365 is available for students to download for free at this website http://bookstore.kirkwood.edu/c-183-office-instructions.aspx. Note: You must use your Kirkwood email when signing up.</p> <p>Web Browser: Google Chrome is the desired web browser for MyITLab. <u>Internet Explorer IS NOT compatible with MyITLab</u>. For any of the web browsers used, you need to ensure that the pop-up blockers are enabled for MyITLab. You may need to set this more than once. - D. Databases - the student will use a computer to create a database, add, change, define, and sort data in the database; retrieve data; and create forms and reports. The student will correctly demonstrate knowledge of databases by storing data in an organized file and quickly retrieving specific information using Access by being able to

 3. Describe the function of the icons on the Standard and Formatting toolbars
 4. Create, save, close, open, and print a database
 5. Create tables and establish a relationship between tables
 6. Sort, filter and query a database
