

DEN103 Lesson Plan: Clinical examination charting

The student will demonstrate proper documentation of existing existing oral conditions using red and blue pencils on a standard clinical examination chart from verbal information given during a mock clinical examination by viewing powerpoint slides.

Students will be presented with a powerpoint lecture: DEN102 Caries and Periodontal Disease.

Lecture will include proper charting techniques to document existing conditions and recommended treatment documentation by using a standard Clinical Examination chart.

After the lecture, slides will be presented which show typical oral conditions of infection and past restorations. The instructor will refer to the slides to present a mock "clinical examination" while giving a verbal assessment of existing conditions and recommended treatment.

Students will demonstrate an understanding of proper use of red and blue pencils to denote decay, existing restorations and recommended treatment, along with proper use of abbreviations for both.

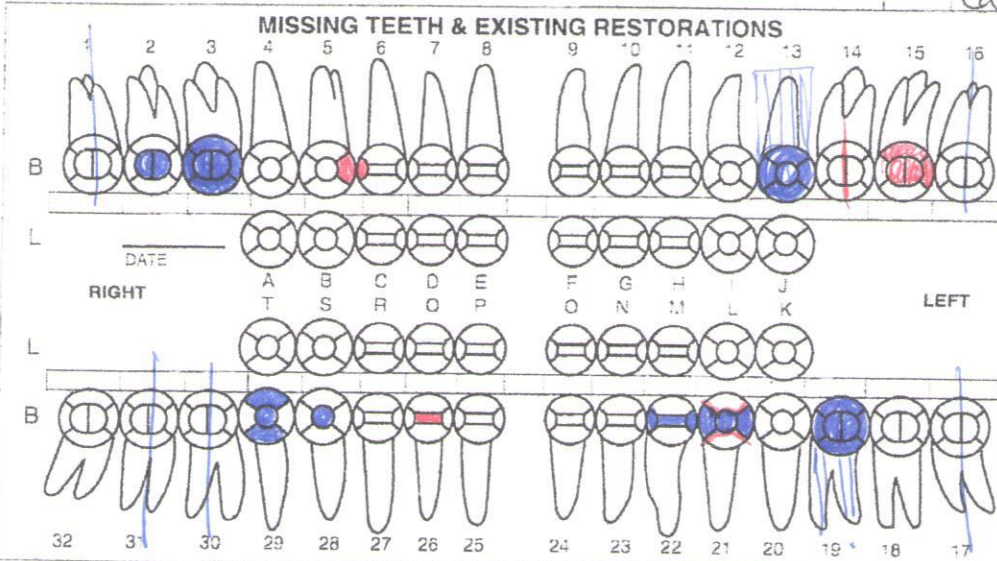
Assessment will be done by having students turn in the "Clinical Examination" charts for grading.
