<u>Catalog Description</u>: Provides for the acquisition and application of mental health nursing theory for safe, evidence-based, patient-centered, holistic nursing care for diverse patients experiencing common acute and chronic mental health disorders and treatment modalities. Includes the application of the concepts of caring, clinical reasoning, quality improvement, communication, and teamwork, considering legal and ethical responsibilities of the nurse when working with patients with mental health disorders.

Two credits theory, one credit clinical. Offered spring semester only. Prerequisites: Admission to the Nursing Program.

## **METHOD OF INSTRUCTION:**

Lecture, discussion, in-class activities, a process recording, a student selfassessment, small group work, Team-Based Learning, videos, selected reference and text readings, written assignments, computer assisted learning programs, and community-based clinical experiences will be utilized.

Team-Based Learning (TBL) is a structured form of small-group learning that emphasizes student preparation out of class and application of knowledge in class. For TBL to be effective, students are required to review content prior to class, take an individual exam at the beginning of each class, and be an active member within a group during discussion and response to the same exam. Most class days will start with TBL testing, although this is up to the discretion of the instructor. Class content will be available within modules on WebCampus. TBL points will be worth 5% of the final grade. Students will receive a *Notification of Unsatisfactory Student Progress* for earning less than a 76% on three (3) TBL individual guizzes.

## THEORY EVALUATION:

Evaluation of student progress will be the successful completion of the course outcomes this will be evaluated with module examinations. Five (4) examinations and a comprehensive final will be given. Questions will be based on utilization of critical thinking skills and application of knowledge acquired in this, as well as previous courses. Questions may be multiple- choice, fill in the blank, choose all correct answers, or other alternate formats as applicable. The cinema project counts as 100 points toward the theory portion of the student's grade and will be completed as a group project with up to 5-6 students per group. Team-based Learning quizzes will count for 5% of the total course grade.

An ATI exam will be given at the end of the course to evaluate student progress and performance. The ATI exam will also serve as an evaluation tool to address any areas of content gaps in course content and correlate with areas of content that were well supported in the course. This exam will account for 10% of the total course grade.

#### **CLINICAL EVALUATION:**

Clinical evaluation is done mutually by student and instructor throughout the semester and in a summative evaluation at the end of the clinical rotation. Postclinical discussion following <u>each</u> clinical experience will be used to help determine your clinical standing (see rubric). Actual clinical performance will be used to determine clinical competency and the ability to generalize and transfer theory outcomes to the clinical settings. Safe clinical practice and demonstration of personal and associate degree nursing practice attributes at the second semester level are mandatory for progression in the program.

#### ATI Real Life Clinical Reasoning Scenarios:

Clinical Reasoning Scenarios provide students with the opportunity to practice clinical reasoning skills. Students experience lifelike clinical situations through the use of video and other forms of rich media. Clinical decision points are

integrated with video segments, requiring students to identify the response the nurse should make. Student choices direct the path of the experience so that each student experiences the consequences of their decisions. Students are required to complete each assigned scenario at a "satisfactory" level or higher.

Course work **must** be completed with an average of 76% or better in both the theory and clinical portions to pass the course. Clinical grades will be averaged into your final grade and count for 25% of your overall course grade.

If you receive less than a 76% on a clinical or theory (other than exams) assignment, you must resubmit a revised version that meets assignment criteria to pass. The original grade will not change after resubmission.

#### Late theory and clinical assignments will be worth 50% of the actual grade. If an assignment is more than one week late, a zero will be given for the assignment but submission of the assignment is still required.

The instructors will make all attempts to have work graded and returned to student within 7 working days from submission date. Please allow more time for larger papers or projects.

## If you do not complete the course and do not formally withdraw by the drop deadline, your instructor will automatically assign you a grade of "F".

## **ATI FINAL EXAM INFORMATION:**

This 70-item test offers an assessment of the basic comprehension and mastery of mental health nursing principles including:

- Basic concepts in mental health nursing (assessment, legal and ethical principles, therapeutic communication, therapeutic nurse-client relationship, anxiety and defense mechanisms, mental health nursing in diverse populations, therapeutic and safe environment)
- Nonpharmacological therapy of mental disorders
- Pharmacological therapy of mental disorders

• Nursing care of clients who have various mental disorders

The student has 70 minutes to complete the assessment.
