Class & Shop: Our welding program is set up as an "open entry" program. This means each student works at his/her own pace. Welding is a skilled trade, therefore, <u>everyone</u> will encounter challenges and our system is designed to give students the flexibility to work through them. It is advantageous for the students to utilize their shop time for welding projects, i.e., <u>do your bookwork at home</u>.

Grades &Each packet is slightly different, the total possible points will vary. FinalTests:grades are determined by the following criteria:

- 15% class attendance & safety
- 20% completion of homework assignments
- 25% combination of both written exam and practical exam
- 40% completion of welding exercises

In order for you to receive a final grade I must have 4 things:

- 1. Homework
- 2. All welding projects completed and grades recorded
- 3. Written Final Exam
- 4. Practical Final Exam
- Attendance:Attendance will be monitored by me at the beginning of each class
period. Each student will receive 3 points per day for attendance.
1 point will be subtracted every time a student is either late or leaves
early. If a student is absent, no points will be earned for that day.

Homework:

-You must turn in the entire packet. From page 1 to the end. I will not accept partial packets.

-Your packets must be 3-ring bound, no staples, no paper clips, and most certainly no loose packets will be accepted.

-Take care of your packets. They are your record of completed projects.

Make up hours: STUDENTS MAY ATTEND SCHEDULED HOURS ONLY, THERE ARE NO MAKE-UP HOURS. YOUR INSTRUCTOR MUST APPROVE ANY CHANGE IN COURSE SCHEDULE.
