## **Certified Medication Technician (CMT)**

The purpose of the Certified Medication Technician (CMT) training program is to prepare individuals for employment as a CMT in an intermediate care or skilled care nursing facility. The program is designed to teach students the skills needed to assist licensed practical nurses or registered professional nurses in medication therapy. CMTs work in long-term care facilities, home health care, agencies and private duty care. Our program teaches you to assist LPNs or RNs in preparing, administrating and charting medications.

The program consists of at least 60 classroom hours of instruction and a minimum of 8-hours of clinical practice under the direct supervision of an instructor.

Unit 1 Basic Review of Body Systems

Unit 2 Body Systems and Medication Effect

Unit 3 Medical Terminology
Unit 4 Infection Control

Unit 5 Medication Classifications

## Student Qualifications:

- •Verification of a high school diploma or a General Education Development (GED) Certificate.
- •Achieves a minimum score of 8.9 on both Vocabulary and Comprehension tests and a minimum score of 7.0 on Mathematics Concepts and Application on the Tests of the Adult Basic Education (TABE). The TABE test is administered by the public education sector.
- •Six (6) months of employment as an approved Certified Nurse Assistant (CNA) and listed as active on the Missouri CNA registry before applying to become a CMT.
- •Submits a letter to the training agency from the student's administrator or director of nursing recommending the student take the course or a letter from a previous long-term care employer if unemployed.
