LAB 1 System Maintenance (Instructor)

Explanation

In this lab, students will demonstrate how to properly clean external computer-hardware and peripherals as well as how to maintain the operating system and hard-drive performance. The idea is that students know how to care for the computer, physically and programmatically, to keep it running smoothly.

While students are cleaning the physical hardware, observe closely and intercede as necessary to prevent any action that could damage computer equipment. For example, immediately stop the student if he/she prepares to spray liquid onto the monitor, or wipe off the keyboard with an excessively wet cloth.

Prompts

- 1. Specifically describe how dirt affects the performance of a mechanical mouse
- 2. What are the three things you should do after spilling liquid on a keyboard?
 - a. Unplug the keyboard
 - b. Turn it upside down to drain
 - c. Rinse the keyboard with running water
- 3. Why is it important to not spray liquid on the monitor screen?
 - a. Because the liquid can seep inside of the monitor. It's best to moisten a cloth with water or an appropriate cleaning solution then wipe the screen
- 4. Is it necessary to manually check for Windows updates often?
- 5. What is the difference between critical and recommended Windows updates?
- 6. Based on the percentage of fragmentation, does your hard-drive need to be optimized?
